(GIRLS)

- 1. The rules as adopted by the Kho-Kho Federation of India apply, with modifications wherever applicable.
- 2. All the matches at Cluster level will be played on Knockout basis. In case the numbers of teams reporting are 8 or less than 8, the tournament may be conducted on league cum knock out basis.
- 3. All the matches at National level shall be played on league cum knock out basis.
- 4. **At National level:** All the teams reporting may be divided into different pools in such a way that by and large no pool is of less than four teams. From each pool, the two teams emerging on top will qualify to play the knock-out stage matches.
- 5. In matches played on league basis, "points for minus the total points against" shall decide the tie. Should the tie still persist; it shall be decided by "spin of coin".
- 6. A team shall consist of a maximum number of twelve players.
- 7. The school Organizing Cluster level competition shall take a Group Photo of the teams that have qualified to participate at National level competition. The photo shall be signed by the host school Principal and forwarded to the school organizing next level of competition along with the original entry Performa.

### **INSTRUCTIONS/GUIDELINES FOR PARTICIPANTS**

- 1. CBSE Cluster-V Kho-Kho (Girls) Championship/Tournament-2025 has been scheduled from 5<sup>th</sup> August to 8<sup>th</sup> August 2025. All matches will be on knock out basis.
- 2. Groups: Under 14, 17 & 19 (Girls).

- 4. Details must be submitted latest by 27/07/2025 for the smooth conduction of the event.
- 5. The **inauguration** of the Championship will be held on 5<sup>th</sup> **August 2025 in between 10 am to 11 am**. The first round of matches will start after the Inauguration Ceremony.
- 6. Teams will be provided accommodation in the school premises. Teams will be responsible for their belongings and are requested not to carry any jewelry, cash or valuable items.
- 7. The girls' team must be escorted by the lady teacher. All teams are requested to bring lock-key, torch, towel, school flag-2, Student Identity card for each player, playing kits.
- 8. Only **vegetarian food** will be served.
- 9. As per CBSE guidelines, each participant has to submit Rs. 500/-per head per day for fooding, lodging and other facilities. However paid canteen will also be functional.
- **10. As per CBSE rules\_** Where the Tournament is being held on knock out basis, the organizing And participating schools may collect/deposit payments against meals together for all the days of Tournament and no part payment will be collected/deposited; or the participating schools will not insist for refund of payment. The teams returning shall be eligible for refund of payment deposited, but only for the post 24 hours balance meal coupons.

## CBSE rules for participants and teacher/staff accompanying them.

No part payment will be accepted. Rs. 2000/- (cash/Two thousand only) per school will be submitted as security deposit which shall be refunded in full at the time of departure in case there is no damage or loss.

10. Important Information:

#### IT SHALL BE MANDATORY-

- (i) To provide the documents for verification in original if asked so for.
- (ii) To provide the team photo with school Principal along with the entry Proforma & Consent form, countersigned by the concerned Principal.
- (iii) For student/player studying in class X and above, must provide CBSE registration number. Eligibility/Entry Proforma & ID Card:
- (iv) Every school must supply the signed copy of eligibility Proforma filled in online to the host school on arrival.
- (v) No team will be allowed to participate without team Manager/Coach.
- (vi) All the competitors shall provide CBSE Registration UID number.
- (vii) *Over age player or player from outside school agency*: In case a school sends an over- age player or player from outside agency, and is caught, the school will immediately be disqualified. And if the same school repeats such act again, its name will be forwarded to the Board's Affiliation Branch for necessary action under Affiliation By Laws.

- All coach/managers and players must have their l-card available at all times.
- After registration, players of any team cannot go out of school without permission.
- If the coach and manager of any team wants to go out of the school, then they have to inform the Organizing Committee.
- No team should have an extra member with them.
- Any friend or relative called by you during the competition will not be allowed to enter the school premises.
- The team members will protect the valuables themselves and if they are lost, the school will not be responsible for them.
- After 8:00 pm, you will not be allowed to enter the school.
- You will fully assist the school cleaner in keeping the school clean.
- Any type of intoxication is prohibited inside the school, and if any student or coach/manager
  is caught taking Gutka, Paanparag, drugs, alcohol etc. then he or she will be punished as per
  rules.
- It is strictly prohibited to order any kind of food inside rooms of the school from outside or canteen. All eatables should be consumed at place/area provided by us.
- If any property of the school is destroyed or damaged by a member of any team, they will be disqualified from the competition and a complain will be lodged to the CBSE Board. We will be strict about it. This is our dream school and anyone damaging it, will not be tolerated. You are our guest but certain etiquettes have to be maintained, as you all are from educated class.
- Whenever a full introduction of any member of your team is asked by the Organizing Committee, you should give full introduction to them, it is mandatory from security point of view.
- Food will not be provided to you without a meal coupon or after the specified time.
- Discipline is the first priority for us. So all the teams are expected to form a line and wait for their turn to get food. If found indiscipline strict action will be taken. It is important to mention here that we have "0" tolerance for indiscipline. Sports teach us discipline so sportsperson is expected to be disciplined.
- Food will not be served after the scheduled time mentioned on coupons. You should maintain time schedule.
- It is mandatory for all team members to participate in the opening ceremony of the competition.
- It is mandatory for all the contestants to wear their school uniform/kit in the opening ceremony of the competition.
- Photographing and recording from mobile or any electronic goods during the competition is strictly prohibited. If you are found recording or photographing, then your mobile or electronic goods which you are using will be seized and action will be taken against you.
- You can take photos of the players while receiving the medals.
- All the teams have to carefully fill the form provided for the participation certificate and submit it to the organizing committee on time. Based on the form only which you have filled, your certificate will be provided to you. No modification will be entertained once you submit your details.

- If you are found troubling other team members with your cell phones or any other electronic gadgets then action will be taken against you.
- As per mentioned time no one is allowed to move around in the school campus for any reason from their respective allotted rooms.

### **DISQUALIFICATIONS**

A player/team may be disqualified/scratched for the following reasons-

- 1. If the ineligibility of any member of the team is detected.
- 2. Inclusion of non bona fide student in the team.
- 3. Misbehavior on ground by athlete or accompanying official.
- 4. Usage of abusive language by athlete or accompanying official.
- 5. Misbehavior with officials/opponents by athlete or accompanying official.
- 6. Indiscipline at the place of stay by athlete or accompanying official.
- 7. Damaging the school property.
- 8. Non-participation in March Past.

The organizing school in no case shall show the eligibility proforma or any other paper of a team to anyone who lodges the protest. It is only jury of appeal's prerogative to verify all the documents.

The organizing school shall submit details of the defaulters to the Jt. Director (Sports) reporting the names of the schools/athletes in a separate cover. All such defaulters will be debarred from the participation in CBSE Inter School Sports and Games Competition for the next year. If any of such schools' resorts to unfair means again, in the subsequent years, it will be debarred for three years.

#### **PROTEST**

Protest of any nature in connection with the tournament shall be in writing and must reach the Organizing Secretary and CBSE Observer within 20 minutes of the declaration of the result, duly accompanied by a fee of Rs. 1000/-. Such a protest will be considered by Jury of Appeal, consisting of the following –

- 1. Principal, Organizing School
- 2. Organizing Secretary
- 3. CBSE observer
- 4. One or two technically qualified people present at the venue

The parties under dispute may be heard before deciding the issue. In case the protest is uphold, the protest fee shall be refunded to the protesting school otherwise the fee shall be forfeited. The decision taken by the Jury of Appeal will be final and binding. The decision, together with full facts of the protest may immediately be reported to the Jt. Director (sports) CBSE.
